

Sponsor a girl and ensure she can go to school



What are the fees for a sponsorship?

25 Euro a month, respectively 35 US-Dollars or 21 British Pounds.

What does my sponsorship mean for the child?

With a sponsorship you enable the child to attend school. The total costs for a school year per child are around 375 Euro. These costs include tuition, school lunches, school uniforms, and writing materials and textbooks.

The \$35 / €25 / £21 sponsorship contribution covers the food, the clothes, and the tuition. The writing and teaching materials will be paid for by other project funds.

What do I have to do to become a sponsor?

Just let us know that you want to sponsor one of the girls – this is all you have to do in the beginning. Then we have to settle the question how you want to transfer the sponsorship fees.

If you have a bank account in Germany, you can fill out the direct debit authorization on the last page of this document. Otherwise you can make a direct bank transfer to our bank accounts in the USA, Germany, Austria or Kenya.

There is also a possibility to pay the fees via www.betterplace.org or PayPal or credit card. Please contact us, and we will find out the best option for you.

In becoming a sponsor, you will receive

The name of the child, a photo, and information on age and attended school.

Will I get to know, how the sponsored child is doing?

At least once a year you will receive a personal letter from your sponsored girl. In addition, we will send you at least once per year a report about the situation on site and the development of Tareto Maa.

Can I contact my sponsored child or visit her?

The correspondence with the sponsored child is a wonderful opportunity to create a more personal relationship. So letters are well appreciated.

Generally, it is also possible to visit the sponsored child. But this has to go along with some preparations. It is important that caregivers of Tareto Maa Kenya are in the process when you meet your sponsored child. The visit should be planned in advance, if possible a few weeks.



Is the sponsorship legally binding?

No, you do not assume any contractual commitments by it – you pay the sponsorship contribution of 25 Euro / 35 USD / 21 £ only as long as you want to. You may terminate your sponsorship without notice at any time (by letter or email).

Are my donations tax deductible?

Tareto Maa USA and Tareto Maa Deutschland (Germany) are registered charities and are allowed to issue donation receipts for tax refunds.

How long does a sponsorship last?

The duration of the sponsorship depends on the number of years that a child still goes to school. But as mentioned above: Personally, you do not undertake any legal commitment and can quit the sponsorship at any time.

What happens to children who do not have a sponsor?

We collect money for Tareto Maa Kenya by different means of fundraising throughout the year – such as donations platforms on the Internet, personal celebrations for which "donations instead of gifts" are asked, or collection boxes in hospitals and medical practices. By these means we do everything we can do to fund education for those children who have not yet found a sponsor.

What are the administrative costs of Tareto Maa?

All members of Maa Tareto in the USA, Germany, and Austria are volunteers and receive no salary. 100% of your sponsorship contributions are sent to Kenya and will support the child – without any drawbacks!
